A Quick Summary of Changes

SENA PN1B2g – Existing Registration Allowance (ERA)

- Major revision to ERA for names.
 - Prior: Only the exact, actual name phrase can be registered under the ERA
 - Current: Only the exact, actual name phrase can be registered under the ERA **EXCEPT** if changes are required to indicate a relationship and that relationship matches a modern, legal relationship **OR** someone wants to change the gender of a registered byname to match the gender of a given name.
- A new appendix Appendix O is created to help when using these exceptions. The appendix is included on the Cover Letter and will not be added to SENA until the Board of Directors approves the revision to PN1B2g in April 2022.

Existing Registration Allowance

- Some important items:
 - The gender of the submitter and the owner of the registered name is irrelevant when determining the legal status of the relationship. For example:
 - A relational byname indicating that a submitter is a daughter of the person whose name
 is already registered only requires that a parent/child relation exists, not that the
 submitter is actually female.
 - A relational byname indicating that the submitter is the grandson of the person whose name is already registered only requires that a grandparent/grandchild relation exists, not that the submitter is actually male.
 - A name element that is considered offensive under PN5B may only be registered to the original owner, not a legal relative. This restriction is new.
 - For example, someone with the registered name Amy the Gypsy could register William the Gypsy but their child could not register that name using the ERA.

Existing Registration Allowance

- More important items
 - Any name submitted under one of the two new exceptions will be decided on a case-by-case basis.
 - If modifying a name element using the relationship exception, make sure to include a letter attesting to the legal relationship or proof of that relationship.
 - Appendix O is neither exhaustive nor exclusive, it is simply meant to provide guidelines for using the ERA. It provides guidelines and examples for how name elements may be modified and still be registered under the ERA.
 - The assumption is that the Board of Directors will approve these changes to PN1B2g therefore names submitted prior to SENA being updated will considered under the standards as stated on the Cover Letter.

Existing Registration Allowance

A few examples:

- Allowed: A daughter of a registered *Hrafn* can register a Demotic Egyptian given name with a patronymic byname, *Djehutyiirdis Hrafnsson*, as a legal parent/child relation exists between Hrafn and Djehutyiirdis.
- Not allowed: A brother of a registered Hrafn can not register a Demotic
 Egyptian given name with a patronymic byname, Sedjemniykhnum Hrafnsson,
 could not be registered, as a legal parent/child relationship does not exist
 between them.
- Allowed: The above brother could register *Sedjemniykhnum Hrafnsbróðir*, as a legal sibling relationship exists between Hrafn and Sedjemniykhnum.

SENA PN2C – Name Requirements

- Name phrases submitted under the legal name allowance are considered gender neutral.
 - We don't need to know the gender of the submitter
 - Legal given names can be used in relational bynames without regard to the gender of the submitter.
 - A legal byname that is gendered (e.g., an inherited or literal matronymic/patronymic) may be used with any given name without regard to the gender of the submitter.
- Also, an editorial change is made in the description of Appendix A;
 this has no effect on registration of names.

Other Changes to SENA

- A2B2c Constructed Monsters: Slight modification to this section of SENA making it easier to register constructed monsters.
- PN2B Name Phase Requirements: Editorial change in the description of Appendix A; this has no effect on registration of names.
- Appendix A Patterns That Do No Need Further Documentation:
 Added double descriptive bynames as a pattern in Old Norse
- **Appendix D** Acceptable Transliteration Systems for Non-Latin Scripts: In Old English the letters ð (edh) and þ (thorn) are generally interchangeable; both may be transcribed as th or d; this need not be consistent in the same name.
 - What this means: Based on a documented Æþelbert the name could be registered as Æþelbert, Æðelbert, Æthelbert, or Ædelbert.

From Pelican: Sounds That Are Similar

- Pelican provided a link to a blog about the International Phonetic Alphabet (IPA) that can help show why some sounds are too similar to register.

- Example: Bond and Pond were ruled too similar in sound. The chart shows B and P in the same cell, meaning that the sounds are produced in the same manner with the same part of the mouth.
- The technical terms are explained at the website.

Where symbols appear in pairs, the one to the right represents a voiced consonant. Shaded areas denote articulations judged impossible.

Consulting heralds are not required to understand IPA – this is simply a tool to help you understand why some things may be ruled "too similar" even if they look different

From Pelican: Classical Arabic Grammar

- Pelican noted that the transliterations most commonly used in the SCA do not show the way the article *al* is pronounced in classical Arabic.
- The article *al* ("the") changes pronunciation depending on whether the next consonant is a "sun" or "moon" consonant. Sun consonants elide into the *al* particle, so al-Zhara is pronounced az-Zhara and al-Rabi' is pronounced al-Rabi'.

- Pelican noted "We encourage people to consider transliterations that include that pronunciation information but remind submitters and heralds alike that any standard transliteration of non-Roman letters is acceptable, as long as the whole name is consistent, per SENA Appendix D."

Updates to the Admin Handbook

- Appendix D will be updated with a standard letter than branches may use to grant permission to conflict for augmentations.
- Permission to conflict is not required when a badge is designated in the O&A as a "standard augmentation" so long as no changes are being made when the badge is used as an augmentation.


From the LoAR: Names

• In the household name Bjarnarstaðir, the designator is —staðir. [Beorn of the Northern Sea, A-Caid]

From the LoAR: Armory

- Jelloped is a blazon term that means the tincture of a bird's wattle [Ismeralda di Lucio, A-An Tir]
- Two pairs of piles issuant from the flanks is a period arrangement of charges. [Ingrid Audadotter, A-Drachenwald]
- There is not a step from core practice for the use of a *natural tiger* since it is found as a period heraldic charge. [Dafydd ap Iorwerth ap Rhodri de dena, A-Lochac]






From the LoAR: New Charges


- Pair of stag beetle's attires proper, a period charge. When proper they are brown.
 At this time no difference will be granted between stag's attires and stag beetle's attires based on their visual similarity. [lago ab Adam, A-An Tir]
- *Nock,* part of an arrow; it is a period artifact. The *nock* registered is a tap-in nock rather than a self-nock. [Lochac, Kingdom of, A-Lochac]
- Catkin, a small, spike-shaped cluster of flowers found in certain kinds of trees. The term is found in period literature to describe this particular part of a tree. At this time there is no difference between catkins and other cones. [Lochac,

Kingdom of, A-Lochac]

From the LoAR: New Charges

- *Qilin,* a fantastical beast of Chinese origin. The depiction includes flames, scales, cloven hooves, ox's tail, and optionally horns. It is registrable with a step from core practice. [Choi Min, A-Middle]
- Mandorla, a period charge that is a variant of a lozenge. [Þórfriðr Hrólfsdóttir, A-Middle]
- Per fess engrailed trefly at the points is a period line of division. Note that the trefoils are at the end of every other point. [Winifred de Canterbury, A-West]
