MIDDLE

Agnes de Tynegate. Name change from holding name Agnes of Cynnabar.

Listed on the LoAR as a new name, the name submission had actually been pended on the September 2005 LoAR and the associated device registered under a holding name. When the pended name was registered, the fact that there was associated armory was forgotten.

September 2006

MIDDLE

Christian Noell. Name change from holding name Cristian of Stonecroft.

Listed on the LoAR as a new name, the name submission had actually been pended on the March 2006 LoAR and the associated device registered under a holding name. When the pended name was registered, the fact that there was associated armory was forgotten.

October 2007

EAST

Adhemar von Kempten. Name change from holding name Michael of Eisental.

Listed on the LoAR as a new name, the name submission had actually been pended on the March 2007 LoAR and the associated device registered under a holding name. When the pended name was registered, the fact that there was associated armory was forgotten.

Cellach Thorn. Name change from holding name Cellach of Flinthyll.

Listed on the LoAR as a new name, the name submission had actually been pended on the April 2007 LoAR and the associated device registered under a holding name. When the pended name was registered, the fact that there was associated armory was forgotten.

May 2011

CAID

Caid, Kingdom of. Badge. Azure, in pale a flame Or issuant from a crescent, a bordure embattled argent.

Blazoned when registered in May 2011 as *Azure, in pale a flame Or issuant from a crescent, a bordure argent*, the complex line of the bordure was accidentally omitted from the blazon.

June 2011

ATENVELDT

Iosif Volkov. Name change from Iosif Volchkov.

Listed on the LoAR as a new name, kingdom failed to note that the item was actually a name change.
His old name, *Iosif Volchkov*, is retained as an alternate name.

EAST

Altani Khatagidai. Name change from holding name Altani of Stonemarche.

Listed on the LoAR as a new name, the name submission had actually been pended on the January 2011 LoAR and the associated device registered under a holding name. When the pended name was registered, the fact that there was associated armory was forgotten.

July 2011

ÆTHELMEARC

Phelippe Ulfdotter. Name change from holding name Phelippe of Misty Highlands.

Listed on the LoAR as a new name, the name submission had actually been pended on the February 2011 LoAR and the associated device registered under a holding name. When the pended name was registered, the fact that there was associated armory was forgotten.

Elena Zekel Miklósne. Name change from holding name Elena of Northkeep.

Listed on the LoAR as a new name, the name submission had actually been pended on the April 2011 LoAR and the associated device registered under a holding name. When the pended name was registered, the fact that there was associated armory was forgotten.
