

Errata

These are corrections to previous LoARs.

August 2012

WEST

Walter Faversham. Reblazon of device. Per chevron embattled argent and vert, two wooden Oriental abacuses proper and a thunderbolt Or.

When reblazoning this device in August 2012 to specify the type of abacus, we omitted that these abacuses are *Oriental* abacuses.

July 2012

LOCHAC

Bret of Abertridwr. Holding name correction from Brett of Abertridwr.

In registering his device, his name was listed on the LoAR as the holding name *Brett of Abertridwr*. The holding name should have been *Bret of Abertridwr* instead.

June 2011

CAID

Eiríkr Mj{o,}ksiglandi Sigurðarson. Name correction from Eiríkr Mjoksiglandi Sigurðarson.

In registering his badge, his name was listed on the LoAR as *Eiríkr Mjoksiglandi Sigurðarson*. The name was registered as *Eiríkr Mj{o,}ksiglandi Sigurðarson* on the May 1998 LoAR.

We note that the online version of the May 1998 LoAR lists the name as *Eiríkr Mjksiglandi Sigurðarson*. The missing {o,} is characteristic of online LoARs from this time period, as they were created from the paper after the fact and many accented characters were omitted.

March 2011

AN TIR

Dezzriane Draganova doch'. Name correction from Dezzriane Draganova doch'.

In registering her device, the name was listed on the LoAR as *Dezzriane Draganova doch'*. The name was registered as *Dezzriane Draganova doch'* on the August 2010 LoAR.

Nerienda Sylvester. Name correction from Nerienda Sylvester.

In registering her device, the name was listed on the LoAR as *Nerienda Sylvester*. The name was registered as *Nerienda Sylvester* on the January 2011 LoAR.

February 2011

ATENVELDT

Michiele MacBean. Name correction from Michièle MacBean.

In registering her device, the name was listed on the LoAR as *Michièle MacBean*. The name was registered as *Michiele MacBean* on the January 2011 LoAR.

May 2010

EAST

Hrothbeorht MacPhie of Dreghorn. Name correction from Hrothbeorhy MacPhie of Dreghorn.

In reblazoning his device, the LoAR listed his name as *Hrothbeorhy MacPhie of Dreghorn*. The name was registered as *Hrothbeorht MacPhie of Dreghorn* on the October 1991 LoAR.

April 2010

EAST

Meadhbh bean mhic Bhrádaigh. Name correction from Meadhbh bean mhic Brádaigh.

In registering her joint badge, the LoAR listed her name as *Meadhbh bean mhic Brádaigh*. The name was registered as *Meadhbh bean mhic Bhrádaigh* as the previous action on that same LoAR.

February 2010

ATLANTIA

Diego Diaz Montañés. Name correction from Diego Diaz de Montañés.

In registering his device, his name was listed on the LoAR as *Diego Diaz de Montañés*. The name was registered as *Diego Diaz Montañés* on the January 2010 LoAR.

October 2009

ATLANTIA

Ceara ní Néill. Name correction from Ceara ni Néill.

Referenced on the LoAR in her device change as *Ceara ni Néill*, the name was registered as *Ceara ní Néill* on the January 1997 LoAR.

Note that the Ordinary and Armorial lists this as having happened in January 2009. Her name does not appear in any form on that LoAR.

As of December 2010, this is now her alternate name. Her primary name is *Isabelle Lafara*.

March 2008

TRIMARIS

B{rv}etislava Je{rv}ábek. Name correction from Bretislava Jerábek.

In registering her badge, her name was listed on the LoAR as *Bretislava Jerábek*. The name was registered as *B{rv}etislava Je{rv}ábek* on the September 1997 LoAR.

November 2007

GLEANN ABHANN

Khal{i-}l ibn ‘Abd al-Ra{h.}m{a-}n. Name correction from Khalil ibn ‘Abd al-Rahman.

In registering his device, the name was listed on the LoAR as *Khalil ibn ‘Abd al-Rahman*, the name was registered as *Khal{i-}l ibn ‘Abd al-Ra{h.}m{a-}n* on the November 2005 LoAR.

The situation is further complicated by the fact that the O&A, noting the incorrect listing on the November 2007 LoAR, lists the name as *Khal{i-}l ibn ‘Abd al-Ra{h.}man*, which is also incorrect.

April 2007

ATLANTIA

Emelyn Pacok. Reblazon of device. Purpure, a peacock tergiant, head to dexter and tail spread, a bordure argent.

Reblazoned in April 2007 as *Purpure, a peacock tergiant, head to dexter and tail spread argent*, the bordure was accidentally dropped.

January 2007

ATLANTIA

Edward Shirebrooke. Name correction from Edward Shirebrook.

Referenced on the LoAR in the registration of a joint badge as *Edward Shirebrook_*, the name was registered as *Edward Shirebrooke* on the May 2002 LoAR.

November 2002

ÆTHELMEARC

Maria Pi{e,}knep{l}ótno. Name correction from Maria Piekneplótno.

Referenced on the LoAR as *Maria Piekneplótno*, the name was registered as *Maria Pi{e,}knep{l}ótno* on the July 1992 LoAR.

Note that the name was corrected in October 2007 to *Maria Pi{e,}kneplótno*, which is missing the slash on the l, but matches what the Ordinary and Armorial has listed for this name. We will be correcting the O&A.

November 1999

ATLANTIA

Aron Nied{z'}wied{z'}. Name correction from Aron Nied{Y:}wied{Y:}.

Referenced twice on the LoAR as *Aron Nied{Y:}wied{Y:}*, the name was registered as *Aron Nied{z'}wied{z'}* on the September 1997 LoAR.

Note that the online version of the November 1999 LoAR is already corrected, but the Ordinary and Armorial is not corrected. We have not been able to find this correction on an errata letter.

Note also that while the online December 1998 LoAR referenced the name as *Aron Neid_weid_*, at the time of this writing, the paper copies sent out were correct and the online version has subsequently been fixed.

TRIMARIS

B{rv}etislava Je{rv}ábek. Name correction from B{u,}etislava Je{u,}{i,}bek.

In registering a device, the name was listed on the LoAR as *B{u,}etislava Je{u,}{i,}bek*. The name was registered as *B{rv}etislava Je{rv}ábek* on the September 1997 LoAR.

Note that the online version of the November 1999 LoAR was corrected: the name appears there as *B{rv}etislava Je{rv}ábek*. However, no correction appears in any errata letter that can be found.

March 1999

TRIMARIS

B{rv}etislava Je{rv}ábek. Name correction from B{rv}etislava Jerabek.

In the acceptance of a badge transfer, the name was listed on the LoAR as *B{rv}etislava Jerabek*. The name was registered as *B{rv}etislava Je{rv}ábek* on the September 1997 LoAR.

October 1998

CAID

D{e-}orwulf s{e-} Deorc. Name correction from Deorwulf se Deorc.

Referenced while correcting the blazon of his device on the errata letter attached to this LoAR as *Deorwulf se Deorc*, the name was registered as *D{e-}orwulf s{e-} Deorc* on the July 1982 LoAR.

June 1995

LAUREL

Owen Tudor. Unprotection of non-SCA device. Gules, a chevron between three helms argent.

Referenced on the LoAR when unprotecting the arms of this historical person as *Owein Tudor*, the form of the name that his device was protected under on the December 1994 LoAR is *Owen Tudor*.

June 1992

ATLANTIA

Muirgel Lyon. Name correction from Murigel Lyon.

In registering a device, the LoAR listed the name as *Murigel Lyon*. The name was registered as *Muirgel Lyon* on the November 1991 LoAR.

OUTLANDS

Aislynn de Darkenhall. Name correction from Aislinn de Darkenall.

Referenced on the LoAR as *Aislinn de Darkenall*, the name was registered as *Aislynn de Darkenhall* on the October 1990 LoAR.

May 1992

AN TIR

Anna Elizabeth von Engelberg. Name correction from Anne Elizabeth von Engelberg.

In registering a badge, the name was referenced on the LoAR as *Anne Elizabeth von Engelberg*. The name was registered as *Anna Elizabeth von Engelberg* on the April 1992 LoAR.

EAST

Amber Stormwolfe. Name correction from Amber Sturmwolf.

In registering a badge, the name was referenced on the LoAR as *Amber Sturmwolf*. The name was registered as *Amber Stormwolfe* on the December 1991 LoAR.

March 1992

ATENVELDT

Wolfgang of Three Needles. Name correction from Wolfgang of the Three Needles.

In registering his device, the name was referenced on the LoAR as *Wolfgang of the Three Needles*. The name was registered as *Wolfgang of Three Needles* on the September 1991 LoAR.

November 1991

MERIDIES

Uilleam MacUilleam of Gairloch. Name correction from Uilleam Mac Uilleam of Gairloch.

In registering a device, the name was referenced on the LoAR as *Uilleam Mac Uilleam of Gairloch*. The name was registered as *Uilleam MacUilleam of Gairloch* on the May 1984 LoAR.

June 1991

WEST

Leticia de Scocia. Name change from Lachlin nic Colin.

In changing the name to *Leticia de Scocia*, the old name was referenced on the LoAR as *Lachlin ni_ Colin*. The old name was registered as *Lachlin nic Colin* on the August 1982 LoAR.

December 1989

EAST

Aonghais Dubh MacTarbh. Name correction from Creachainn, Clan.

Referenced on the LoAR as *Creachainn, Clann*, the name was registered as *Creachainn, Clan_* on the July 1974 LoAR.

November 1989

ATLANTIA

Serena Verran. Name correction from Serena Verra.

In registering a device, the name was referenced on the LoAR as *Serena Verra_*. The name was registered as *Serena Verran_* on the February 1984 LoAR.

WEST

Maredudd Goch ap Llywelyn ap Cadwallon Gwythernion. Name correction from Maredudd Goch ap Llywelyn ap Cadwallon Gwythryinion.

Referenced on the LoAR in a device change as *Maredudd Goch ap Llywelyn ap Cadwallon Gwythryinion*, the name was registered as *Maredudd Goch ap Llywelyn ap Cadwallon Gwythernion* on the May 1987 LoAR.

March 1989

CAID

Ann Marie du Moineau Chantant. Name correction from Ann Marie du Moineau Chateau.

Referenced on the LoAR when registering a badge as *Ann Marie du Moineau Chateau*, the name was registered as *Ann Marie du Moineau Chantant* on the October 1982 LoAR.

November 1988

MIDDLE

Seónag Sørensdatter. Name correction from Seónag S rensdatter.

Referenced on the LoAR as *Seónag S rensdatter*, the name should have been registered as *Seónag Sørensdatter* on the November 1988 LoAR. Unfortunately, this was in the era where letters with diacriticals were added to the paper manually, and this letter was missed.

Note that the online version of this LoAR lists the name as *Seónag Sfrønsdatter*. This is also incorrect.
