Brunissende Dragonette has offered considerable effort and service throughout her tenure as Wreath Queen of Arms. I therefore confer upon her the rank and style of Herald Extraordinary, and charge her to register a title of her choosing with the College of Arms.

We are all no doubt grateful for Bruni's service, but perhaps none so much as me, who was quite happy she succeeded me as Wreath. Enjoy your retirement, Bruni, but not too much!
