To all the College of Arms and all others who may read this missive, from Juliana Laurel, Alys Pelican, and Cormac Wreath, greetings.

From Pelican: Hamlets

The Kingdoms of Lochac and Drachenwald both use the term "Hamlet" to apply to entities that fall somewhere between branches and households. No one had attempted to register names for these entities until recently. Therefore, the Laurel office had not established policy for whether and how names for Hamlets should be registered.

The Barony of Southron Gaard within the Kingdom of Lochac submitted two Hamlet names over the last several months. The name *Hamlet of Gildenwick* appeared on the June 26, 2017, Lochac Letter of Intent and then on the November 2017 Letter of Pends and Discussion. The name *Hamlet of Wildmoor* appeared on the October 24, 2017, Lochac Letter of Intent; it was pended awaiting the outcome of the larger discussion on Hamlets. Having now received instructions from the Board of Directors concerning the status of Hamlets, decisions on these two specific Hamlet names are included in this month's Letter of Acceptances and Returns.

Effective as of the date of issuance of this Letter, registration of the names of Hamlets is subject to the following rules:

- 1. Only Lochac and Drachenwald may submit names and badges for Hamlets. Any other Kingdom wishing to do so must first obtain the same variance from the Board of Directors as Lochac and Drachenwald.
- 2. Hamlet names are considered branch names for the purposes of the College of Arms. *Hamlet* is the designator and the substantive elements of the name must be appropriate for a place name.
- 3. *Hamlet of* is considered neutral in language and time period, just like any other branch name designator. Because of the special status of Hamlets we are not currently accepting translations of the term "hamlet" into other languages.
- 4. Hamlets may register badges but they may not register arms.
- 5. Hamlets may not display a laurel wreath as part of their armory unless and until they transition to being official SCA branches.
- 6. A petition of support will be required to register a name or badge for a Hamlet. We are consulting with Lochac and Drachenwald about the most practical form of such a petition given the special status of Hamlets.

From Pelican: Colors in French Inn-Sign Names

This month we dealth with the question of whether a household name based French inn-sign patterns could use the heraldic color term *sable*. French inn-sign names such as *la maison du Chappeau rouge*, *l'enseigne de la Rose blanche* use ordinary vernacular color terms to describe the heraldic charges. Thus, until evidence is found supporting the use of heraldic tinctures in French inn-sign names, French household names relying on the pattern heraldic charge + color must use vernacular color terms such as *rouge* and *blanche* as opposed to heraldic tincture terms.

The color terms *Or* and *argent* were used both as terms for heraldic tinctures and ordinary color terms. Thus, they may be used in inn-sign household names. In addition, period examples of period French inn-sign names show these color terms were used with the preposition *de*: for example, *hostel du Lion d'argent* and *l'enseigne de la Croix d'or*.

We welcome additional research on the subject of French household names and naming patterns.

From Wreath: Bisciones

A submission this month asked us to consider whether the motif of a serpent glissant palewise vorant of a demi-human was sufficiently peculiar to the Visconti family and their supporters that use of the motif should be considered presumptuous under SENA A6B1. The charge combination, blazoned by the Italians as a biscione, was used by the Visconti family almost exclusively, and chiefs of allegiance displaying the biscione were used by Visconti supporters, indicating that use in SCA armory in any form would be presumptuous. However, the tinctures of the serpent were exclusively vert or azure when used for this purpose. Therefore, we are adding the biscione, defined for our purposes as a serpent glissant palewise (vert or azure) vorant of a demi-human (of any tincture), to the list of restricted charges.

From Laurel: A Herald Extraordinary

The College of Arms has a rank of Herald Extraordinary that has a long and honored history. The rank was formally created and defined in the July 1981 cover letter by Wilhelm Laurel. The intent of the rank is to recognize and reward "... those heralds who have greatly served the College of Heralds and/or the College of Arms and have achieved the highest level of competence in heraldry."

There are a handful of people who have served for many years as our experts on specific topics and it is right that they be recognized. Ælfwynn Leoflæde dohtor is one of those people: she has been the go-to person on German names since before I stepped up as Pelican in 2010 and has continued that to the present. She's always been there, even though our meetings run deep into the evening in Drachenwald. For that invaluable long-term service, it pleases me to confer upon her the rank and style of Herald Extraordinary, and charge her to register a title of her choosing with the College of Arms.

He was a former Triskele Principal Herald and a great pillar of the College of Heralds of Trimaris.
