These are corrections to previous LoARs.

# October 1976

### West

Gangenrath Woodwender of the North March. Name correction from Gangenrath Woodwender.

When this name was registered, the LoAR listed his name without the locative. As it is on all of his forms as well as the notification of registration letter sent to him later, we have restored the locative.

### July 1980

### East

**Roderick of Basing.** Badge. Argent, upon an unbarbed rose azure another argent, seeded Or. When this badge was registered, the LoAR erroneously listed this as a device instead of a badge.

### January 1983

# Caid

**Damon of the Lake that Flames.** Name and badge. Argent, in pale a flame of nine points to chief gules and a cartouche fesswise azure.

When this badge was registered, the decision text on the LoAR was clear that this is a badge, not a device. The LoAR neglected to note in the action type that it was a badge, so we are clarifying that now.

### June 1990

### East

Abu Mohammed Hassan. Name change from Jean Honnête le Bouquiniste.

When this name change was registered, the LoAR misspelled the previous name as *Jean Honnête le Bouq\_iniste*.

### September 1992

East

Astrach yo Zhar-Ptitsa. Reblazon of badge for Rodina. Gules, a sword issuant from a flame voided Or. When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

# June 2010

### East

Astrach yo Zhar-Ptitsa. Reblazon of badge for Rodina. Gules, in pale a sword issuant from a flame voided Or. When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

### April 1998

#### Middle

Catherine Margaret Oakley of Rivendale. Device change. Per pall argent, sable, and vert, a Catherine's wheel and an oak leaf argent.

When her device was registered, the LoAR neglected to note it was a device change, not a new device. The submitter's previous device, *Per pale vert and sable, a Catherine's wheel and an oak leaf, a chief triangular argent*, is retained as a badge.

#### December 1998

### Middle

SkallaGormr Berserkr. Device change. Per pale sable and azure, a cockroach argent.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Per pale sable and gules, a frauenadler displayed with human arms maintaining in chief two swords argent*, is released.

### January 2000

### Atlantia

Uilliam MacCloskey. Device change. Ermine, a bear statant, on a chief sable three roses argent.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Per pale indented purpure and Or, a fountain between two bears combattant counterchanged*, is released.

#### November 2000

#### East

Anne of Framlingham. Device change. Lozengy gules and argent semy of keys palewise wards to dexter base, a chief sable.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. The submitter was contacted and requested that the previous device, *Ermine, a falcon rising contourny, wings addorsed, belled and jessed gules and a chief vert*, be released.

### August 2001

### Trimaris

Énnae Catha an Dúna. Name and device. Sable, a sword between two lion's heads erased respectant Or. Listed when registered on the LoAR as a name change from *Innis McCothas*, there is no evidence that name was ever registered. We are correcting the action type to a new name and device.

### June 2002

### AEthelmearc

**Fiona Harpar.** Device change. Argent, an acorn vert within a bordure wavy sable semy of oak leaves argent. When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Per pale vert and argent, an open book between three Celtic crosses counterchanged* is retained as a badge.

### November 2002

#### Atlantia

Elspeth Macalpin. Device change. Vert, a hare sejant erect and a sinister tierce Or.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Or*, *a needle bendwise threaded sable, a chief embattled vert*, is released.

### July 2003

### Caid

Robert Crosar. Device change. Per chevron gules and argent, two thistles Or and a bear rampant sable.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Per fess purpure and vert, two bendlets and two scarpes fretted, in pale three thistles in pale Or*, is released.

#### September 2003

### An Tir

Morgan of Aberystwyth. Reblazon of badge. Gules, a baby sea-loat rampant Or.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

# December 2003

### West

Artus Quintus. Device change. Argent, a chi-rho and a bordure gules.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the Letter of Intent, the previous device, *Azure, ermined, a fox courant and on a chief indented argent, three celtic crosses azure*, is released.

### February 2004

# Atlantia

Geoffrey Athos von Ulm. Device change. Gules, a dolphin haurient between flaunches argent.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Sable, a dolphin haurient between two flaunches Or, each charged with a Maltese cross fitchy sable*, is retained as a badge.

### November 2004

### East

**Rupert the Unbalanced.** Device change. Or, a chevron gules between in chief two pairs of arrows inverted in saltire and in base three goblets one and two sable.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Or goutty de sang, three cups sable*, is retained as a badge.

### Middle

**Rinaldo of Blackhaven.** Reblazon of badge for Household of the Dark Winds. Or, a pegasus salient sable sustaining and ridden by a man in armor vert maintaining a sword sable.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

# April 2006

West

Morgillian of Greenbough. Reblazon of badge. Or, a pinecone, stem to chief vert.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

### May 2006

### West

**Janet Breakstone.** Reblazon of badge. Azure, a brunette harpy displayed proper, the avian part argent, maintaining in its dexter talon a skull argent.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

### June 2009

### Atenveldt

Britha of the Unicorn's Forest. Reblazon of badge. Argent, a unicorn couchant argent fimbriated and with details delineated azure.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

### July 2010

### East

**Thylacinus Aquila of Dair Eidand.** Reblazon of badge. (Fieldless) An eagle rising sable bellied, headed, and detailed argent fimbriated of flames proper.

Originally reblazoned on the April 2010 LoAR, that reblazoning was corrected in an errata in July 2010. However, the original and the errata both erroneously listed this as a device instead of a badge. We are choosing to only errata the most recent errata action to correct the inaccurate item type.

### December 2010

### Ansteorra

**Peregrine of the Crescent Hawks.** Reblazon of badge. (Fieldless) In pale a hawk rising to sinister gules grasping in its feet a horn Or.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

### March 2011

### Atenveldt

**Dietrich Kurneck von Hammerstein.** Reblazon of badge. (Fieldless) A sinister mailed fist aversant sable sustaining stalks of grain Or.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

### August 2011

# Middle

**Eadwine be Bocce Sele.** Reblazon of badge. Ermine, a wyvern erect azure, maintaining in both legs a partly open book argent bound gules.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

#### February 2012

West

**Tristan Halsson fra Ravnsborg.** Reblazon of badge. Argent, a giant dung beetle statant sable. When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

### June 2012

West

**Melissa Kendal of Westmoreland.** Reblazon of badge. (Fieldless) A quill pen bendwise sinister sable ribbed gules.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

### August 2012

### Atenveldt

**John the Idiota.** Reblazon of badge. Gules, a woolly spider monkey rampant grasping with its upraised tail a pouch Or.

When reblazoned, the LoAR erroneously listed this as a device instead of a badge.

### July 2013

### Caid

Claude Laudin. Device change. Or, two piles inverted each tipped with a cinquefoil pierced vert.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Or*, *a rose and on a chief invected vert three compass stars Or*, is retained as a badge.

# March 2014

# Calontir

**Persephone Odymsy.** Device change. Vert, three estoiles argent each within and conjoined to a mascle, issuant from base a demi-sun Or.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Azure, three roundels and a demi-sun issuant from base Or*, is retained as a badge.

# April 2014

### Lochac

Yves de Lyle. Device change. Counter-ermine, a pale ermine, overall a phoenix Or rising from flames gules.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Azure, a phoenix Or issuing from flames gules within an orle of fleurs-de-lys argent*, is released.

### February 2015

### Middle

Maaicke van Zanten. Device change. Argent, the kanji for "bright" and a base wavy azure.

When this device was registered, the LoAR neglected to note this was a device change instead of a new device. This was a resubmission of the same design from a previous return for conflict; while this submission form was merely marked as a resubmission, not a change, the original form was marked as a change and to release the old device. The submitter was contacted and reaffirmed the desire to release the old device. Therefore, the previous device, *Per pale Or and sable, two dogs rampant addorsed counterchanged, breathing flames gules, on a chief nebuly azure an egg between two acorns Or*, is released.

### August 2016

West

**Gwyneth Fitz-Rolf.** Name correction from Gwyneth fitz-Rolf and device change. Argent, a polypus sable between three mullets azure.

When this device change was registered, the LoAR neglected to note the disposition of the previous device. Per the instructions on the form, the previous device, *Argent, between three mullets azure a rampion stalk (Campanula rapunculus) proper*, is retained as a badge. The LoAR also misspelled the byname, which we are correcting here.

# October 2016

### Atlantia

Hannus Siltanen. Device change. Per pale azure and vert, a lynx passant argent marked sable, on a chief argent three Bowen knots vert.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Per pale gules and vert, a stag trippant and on a chief argent three Bowen knots vert*, is released.

### December 2016

### Outlands

**Cecilia Caterina da Firenze.** Device change. Per chevron purpure and argent, three fleurs-de-lys argent and a domestic cat sejant gardant sable.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Argent, two arrows in saltire surmounted by a feather vert, a bordure embattled purpure*, is released.

### July 2017

### Lochac

Mery of Ellersly. Device change. Vert, in pale two boots, an orle argent.

When this device was registered, the LoAR neglected to note it was a device change, not a new device. Per the instructions on the form, the previous device, *Per chevron engrailed azure and argent, three elder flowers argent barbed and seeded Or and a tree proper*, is retained as a badge.

### November 2018

### Lochac

**Gwyneth ferch Aeddan.** Device change. Azure, an oak tree Or atop a base vert, in chief three mullets of eight points argent.

When this was registered, the LoAR neglected to note it was a device change. The disposition of the previous device, *Vert, an acorn Or in chief three mullets argent*, was listed on the LoAR; it was retained as a badge.
