Louis-Philippe Mitouard. Name correction from Louis-Philippe Mitourard.

The name was listed on the LoAR as Louis-Philippe Mitourard, but both the forms and the LoI show Louis-Philippe Mitouard.

February 1981

CAID

Fia Naheed. Name.

The LoAR noted her device registration but failed to note the name registration.

September 1984

CAID

Sven Magnusson. Name.

The LoAR noted his device registration but failed to note the name registration.

January 1985

EAST

Etta von Felsenstrand. Blazon correction. Barry wavy argent and azure, two sea unicorns combattant within a bordure gules.

The LoAR misspelled "unicorns" as "uniorns".

January 1986

MIDDLE

Greyhope, Shire of. Name correction from Grey Hope, Shire of.

The name was misspelled on the LoAR as $Grey\underline{Hope}$, $Shire\ of$; the forms and the LoI showed $Grey\underline{hope}$, $Shire\ of$.

February 1987

MIDDLE

Greyhope, Shire of. Return of name.

This branch's name was registered in 1986 (see name correction above); therefore this resubmission should have been returned as this branch's name was already registered.

Rokkehealdan, Shire of. Name correction from Rokkehealden, Shire of.

The name was misspelled as Rokkehealden, Shire of. It was registered in July 1979 as Rokkehealdan, Shire of.

September 1988

CAID

Fredrick of Woodlyn. Household name House Woodlyn.

The household name was accepted in 1988, but the LoAR noted it only as a designation. This household name is associated with the already registered badge *Argent, a bordure urdy vert*.

Fredrick of Woodlyn. Household name Woodlyn Library.

The household name was accepted in 1988, but the LoAR did noted it only as a designation. This household name is associated with the already registered badge *Argent, an open book within a bordure urdy vert*.

April 1989

OUTLANDS

Outlands, Kingdom of the. Order name Order of the Golden Pheon.

The LoAR failed to note the order name registration when the associated badge was registered. This order name is associated with the already registered badge *Vert, a pheon inverted environed of a stag's attire, all within a bordure embattled Or.*

Outlands, Kingdom of the. Order name Award of the Protector of the Queen's Heart.

The LoAR noted failed to note the order name registration when the associated badge was registered. This order name is associated with the already registered badge *Vert, two rapiers inverted proper, overall a heart, all within a bordure embattled Or.*

Outlands, Kingdom of the. Order name Order of the Trefoil.

The LoAR noted failed to note the order name registration when the associated badge was registered. This order name is associated with the already registered badge *Vert, a trefoil slipped argent within a bordure embattled Or*.

Outlands, Kingdom of the. Order name Order of the Venerable Guard.

The LoAR noted failed to note the order name registration when the associated badge was registered. This order name is associated with the already registered badge *Vert*, a sheaf of three swords inverted proper surmounted by a rose, all within a bordure embattled Or.

Outlands, Kingdom of the. Order name Order of the White Scarf of the Outlands.

The LoAR noted failed to note the order name registration when the associated badge was registered. This order name is associated with the already registered badge *Sable*, on a pale argent between two rapiers proper, a stag's antler vert.

June 1990

CAID

Ragnar Torbjörn. Name.

The LoAR noted his badge registration but failed to note the name registration.

July 1990

CAID

Iain Glic MacRobert. Name.

The LoAR noted his device registration but failed to note the name registration.

September 1990

ANSTEORRA

Thorland O'Shea. Blazon correction. Per pale sable and gules, a tau cross within an orle argent.

The LoAR omitted the comma after the field description.

February 1992

OUTLANDS

Iric Iulian of Black Elk. Name correction from Irik Julian of Black Elk.

In registering his device, the LoAR misspelled his name as *Iri<u>k</u> Julian of Black Elk*. His name was registered as *Iri<u>c</u> Julian of Black Elk* in January 1990.

January 1994

AN TIR

Aelfgifu Wolfsängerin. Release of badge. Vert, a wolf sejant ululant within a bordure argent.

The LoAR registered this as a device, but failed to release the identical badge.

January 1996

ATLANTIA

Jonathan Blackbow. Blazon correction. Or, on a pile raguly vert in chief a broadarrow inverted argent and surmounted by a bow drawn fesswise sable.

The word "surmounted" was misspelled as "suramounted" on the LoAR.

June 2002

ATLANTIA

Caitlyn O'Duirnin. Name correction from Caitlyn o Duirnin.

In the transfer and acceptance of transfer of the household name *House Azami* from *Ysabeau Cameron* and *Laeghaire O Laverty* to *Ranulf of Waterford* and *Caitlyn O'Duirnin*, Caitlyn's name was misspelled. Her name was registered as *Caitlyn O'Duirnin* in January 1989.

MERIDIES

Anna Genevieve of Ancyra. Name change from Melek of Ancyra.

Her old name was misspelled on the LoAR as *Melek of Ancrya*. Her old name, *Melek of Ancyra*, is released.

February 2003

EAST

Tessa Bonchavel. Name change from Tessa Chavel.

The LoAR did not include a disposition for her former name. Her former name is released.

March 2003

WEST

Catalina Estevez de Teixeira. Alternative name Stephen of the Yews.

When her current name, *Catalina Estevez de Texeira*, was registered, the LoAR released her old name, *Stephen of the Yews*. However, she wished to retain it as an alternative name.

April 2003

MIDDLE

Moraig Anne Drummond. Name correction from Moraig Ann Drummond.

In registering her acceptance of a badge transfer from the Principality of Northshield, the LoAR misspelled her name as *Moraig An<u>n</u> Drummond*. Her name was registered as *Moraig An<u>ne</u> Drummond* in August 1988.

Anne Marguerite Gobelin. Name.

The LoAR noted her device registration but failed to note her name registration.
