May 1999

West

Merewen the Dark. Blazon correction. Per chevron sable and azure, two suns and a crescent Or.
The LoAR misspelled "suns".

November 1979

EAST

Janina Krakowska. Name correction from Jamina Krakowska.
Listed on the LoAR as *Jamina Krakowska*, the forms and the LoI listed *Janina*.

July 2004

An Tir

Katin inghean Neachtain. Name correction. (Fieldless) On an open scroll fesswise argent a cat couchant contourny sable.
Listed on the LoAR as *Katin inghean Neachtan*, her name was registered as *Katin inghean Neachtain* on that LoAR.

Kieran Moncreiff of Dundee. Name correction. Azure, on a chevron fracted argent five triquetras azure and on a chief embattled argent three crosses clechy azure.
Listed on the LoAR as *Kieran Moncrieff of Dundee*, his name was registered as *Kieran Moncreiff of Dundee* on the April 2003 LoAR.

Atenveldt

Tairdelbach mac Conchobair. Name correction. Azure, four claymores inverted interlaced as a fret interlaced by a claymore inverted and a chief Or.
Listed on the LoAR as *Tearlach mac Conchobair*, his name was registered as *Tairdelbach mac Conchobair* on the June 2004 LoAR.

Atlantia

Anna van Brabandt. Name correction. Per saltire argent and Or, a tulip flower sable.
Listed on the LoI as *Anna de Brabant*, her name was registered as *Anna van Brabandt* on the May 2004 LoAR.

Ealdormere

Lachlan MacLean. Name correction. Azure, six daggers conjoined at the pommels points outwards proper, within an orle Or, on a chief Or, two dragons statant respectant azure.
Listed on the LoI as *Lachlan Maclean*, his name was registered as *Lachlan MacLean* on the August 2003 LoAR.

September 2004

Æthelmearc

Ældric de Logan. Name correction. (Fieldless) A griffin couchant to sinister argent.

Listed on the LoAR as *Ældric of Logan*, his name was registered on that LoAR as *Ældric de Logan*.

East

Rosamund d'Alwareton. Name correction. (Fieldless) A rose sable within and conjoined to a chaplet of thorns vert.

Listed on the LoAR as *Rosamund D'Alwareton*, her name was registered as *Rosamund d'Alwareton* on the November 1990 LoAR.

February 2005

Caid

Oisséne na Cenn mac Baiscind. Name correction.

The LoAR noted that the submitted name was changed to *Oisséne na Cenn mac Baiscind*; the header mistakenly listed *Oisséne na gCeann mac Baiscind*

March 2005

Northshield

Northshield, Kingdom of. Badge. (Fieldless) An eagle per pale Or and sable maintaining a lightning bolt sable and a lightning bolt Or.

Listed on the LoAR as a badge for Order of the Aquila, that order name was returned on the January 2005 LoAR.

Northshield, Kingdom of. Badge. (Fieldless) A swan naiant contourny Or.

Listed on the LoAR as a badge for the Award of the Cygnus, that order name was returned on the January 2005 LoAR.

Northshield, Kingdom of. Badge. (Fieldless) In fess a sword argent sustained by a griffin Or.

Listed on the LoAR as a badge for the Award of the Griffins Sword, that order name was returned on the January 2005 LoAR.

Northshield, Kingdom of. Badge. (Fieldless) In fess a sword sustained by a griffin sable.

Listed on the LoAR as a badge for the Iron Griffin Legion, that order name was returned on the January 2005 LoAR.

Nuala inghean uí Chaoindealbhain. Name correction from *Nuala inghean uí Chaoinleáin*. Gules, a pegasus segreant, on a chief wavy argent, three quatrefoils vert.

Listed on the LoAR as *Nuala inghean uí Chaoinleáin*, her name was corrected to *Nuala inghean uí Chaoindealbhain* on the February 2005 errata letter.

April 2005

ANSTEORRA

Skorragarðr, Canton of. Name correction. Purpure, a bend between two pairs of wings conjoined in lure, each within a laurel wreath argent.

Listed on the LoAR as *Skarrgarðr, Canton of*, their name was registered as *Skorragarðr, Canton of* on the December 2004 LoAR.
