Not all letters of intent may be considered when they are originally scheduled on this cover letter. The date of mailing of the LoI, date of receipt of the Laurel packet, or other factors may delay consideration of certain letters of intent. Additionally, some letters of intent received may not have been scheduled because the administrative requirements (receipt of the forms packet, receipt of the necessary fees, et cetera) have not yet been met.

REMINDER: Until all administrative requirements are met, the letter may not be scheduled.

FROM LAUREL - KWHSS 2008 in Drachenwald

The bid for Known World Heraldic Symposium 2008 has been awarded to the Shire of Thamesreach in the Kingdom of Drachenwald. The event will be held the weekend of September 5-7, 2008 at University College, London. The entire text of the event bid may be reviewed on OSCAR; you will recall that it is posted as a 'Laurel Other' letter dated January 10, 2007.

September is not the traditional time of year for Symposium, but this date allows us to take advantage of lower costs, fewer crowds and the accommodations at University College. Because of this I am departing from tradition again and making this announcement now, rather than waiting until this year's Symposium to do so. Since this will involve far travel for many members of the College of Arms, it made sense to give everyone had as much time as possible to prepare for it.

I am looking forward to seeing many of you there. This is a tremendous opportunity for us all and I thank the autocrat and her team for making it possible.

FROM LAUREL - Attention Principal Heralds - New Commenters on OSCAR

The following is a change to the Administrative Handbook, VII.A.6. --

"Other Commenters nominated by the Principal Herald of their kingdom of residence and ratified by the Laurel Sovereign of Arms after they have met the requirements established by their kingdom's College of Heralds. On a case by case basis, Laurel may waive the requirement for such nomination, such as in the case of former College of Arms commenters."

Before OSCAR, a Kingdom could only maintain at most a handful of CoA commenters. Now we have the potential to easily add many more, which is good-that is one of the reasons OSCAR was established in the first place. But this needs to be done through each Kingdom's Principal Herald, as per the Administrative Handbook, and some kind of traffic control is necessary.

As per the Administrative Handbook VIII.B.8, "Any changes in administrative rules or procedures must be published in a cover letter to the letter of acceptances and returns." Therefore, as of publication of this letter, each individual Principal Herald shall work with his or her College to establish guidelines for new CoA level commenters. These need not be long or elaborate, but they they must outline at least some basic level of skill and experience. They should also be well publicized and periodically reviewed.

I will expect to see each Kingdom's proposed guidelines as part of the Principal Herald's report due the end of May 2007.
FROM LAUREL - New Form Letters
The following are additions to the Administrative Handbook, Appendix D, 'Suggested Standard Form Letters.' Many thanks to Mari Rowel for coordinating this process.
- Letter of Transfer (Name)
I, [Legal name], known in the SCA as [Society name], do transfer to [Legal name of submitter], known in the SCA as [Society name of submitter], the following [household/personal] name "[Registered name]". I understand that this transfer cannot be withdrawn once made.

- Letter of Transfer (Armory)
I, [Legal name], known in the SCA as [Society name], do transfer to [Legal name of submitter], known in the SCA as [Society name of submitter], the following armory "[Blazon of registered armory]". I understand that this transfer cannot be withdrawn once made.

- Letter of Acceptance of Transfer (Name)
I, [Legal name], known in the SCA as ([Society name]) do accept the transfer from [Legal name of submitter], known in the SCA as ([Society name of submitter]) the following [household/personal] name "[Registered name]". I understand that this transfer cannot be withdrawn once made.

- Letter of Acceptance of Transfer (Armory)

- Letter Documenting Legal Relationship for Grandfather Clause
- I, [Legal name], known in the SCA as [Society name], do attest that [Legal name of submitter], known in the SCA as [Society name of submitter], is my legal [father/mother/wife/husband/son/daughter/brother/sister]. I understand that this letter cannot be withdrawn once [Legal name of submitter]'s name is registered.

(Background: The "Grandfather Clause", RfS II.5, was extended to include immediate family in the precedent: "[W]e allow the original submitter to register further instances of the problematic element provided that they introduce no new violations of the rules; and secondly, we extend the allowance to the original submitter's nearest kin." (Roxanne Blackfeather, East-R, LoAR December 1995, p. 20). This template provides a method to document the legal immediate family relationship required for use of this extension of the Grandfather Clause. Alternatively, the submitter may provide a photocopy of a legal document(s) that demonstrates the relationship.)

- Letter of Permission to Presume

I, [Legal name], known in the SCA as [Society name], give [Legal name of submitter], known in the SCA as [Society name of submitter], permission for my Society name to be used in part of [his/her] Society name in order to indicate a relationship. I understand that this permission cannot be withdrawn once [Legal name of submitter]'s name is registered.

(Note: Permission to Presume may be granted to anyone, not simply legal relatives, and so is often used to indicate SCA relationships, such as those in a household. For example, when Owen ap Aeddan ap Trahaearne registered his name in 12/1998, he needed a letter from Aeddan ap Trahaearn whose name was registered 07/1996, giving Owen permission to presume because Owen's name indicates that he is the son of Aeddan ap Trahaearn.

From Pelican: On Household Name Formation

In recent months, many household names have been submitted without documentation showing that they follow a specific naming pattern for organized groups of people at a specific time in a specific culture. In one instance, the submitter merely noted "the specific allowance for household names composed of a household designator and surname in the *Rules for Submissions*."

Folks -- this has got to stop. RfS III.2.b.iv says:

iv. Household Names - Household names must follow the patterns of period names of organized groups of people.

Possible models include Scottish clans (*Clan Stewart*), ruling dynasties (*House of Anjou*), professional guilds (*Bakers Guild of Augsburg*, *Worshipful Company of Coopers*), military units (*The White Company*), and inns (*House of the White Hart*).

The models are specific models for specific times and places, not models appropriate for every time and place. For example, *House of the White Hart* is an English sign name. There is ample documentation for household names based on surnames and of surnames based on sign names in England. However, to register a name following this pattern in Italian or Spanish, the submitter would need to demonstrate a pattern in these languages of names derived from inn-signs as well as household names derived from surnames (although the latter of these two should be fairly easy).

Names that are inadequately documented may be returned. Please make sure to provide documentation that the pattern used in a submitted household name is appropriate for the language and culture of that name.

From Wreath: On Fishhooks

While there are very few registrations of fishhooks, we have been inconsistent in how we blazon them. This is one of the few charges that cannot be blazoned unless you assume a default orientation. The question becomes, what is that default?

The defining instance of a fishhook (Mons Draconis's badge, March 2000) was taken from Gelre, f.41v, where it's given as the arms of von Borne or Born. The (modern French) blazon in the index of Gelre is: d'argent au croc de hameçon de gueules (Argent, a fishhook gules). It has the couped end to base, the curved end to chief; the barbed point is on the dexter side, inside the curve of the hook.

Guillim's "Display of Heraldrie", 1632, p.319, gives an example of fishhooks: "He beareth, Sable, a Cheveron between three Fishing Hookes, Argent, by the name of Medvile." The shape is the same as in von Born, but inverted: the couped end is to chief, though the opening with the barb is still to dexter. Note that Medvile's fishhooks aren't blazoned as "inverted": they are in what Guillim considers the default posture.

A similar fishhook is found in Siebmacher's "Wappenbuch", 1605, in the arms of von Angelloch (pl.125). It matches Guillim's depiction of a fishhook in its appearance: a bit slenderer than von Born, but with couped end to chief. The opening is depicted to sinister, but Siebmacher always turned the shields (including the charges, helms and crests) in the first and fourth column of each page to face sinister; its normal depiction would therefore be with the opening to dexter, just as in Guillim's depiction.

Parker also mentions fishhooks (p.330, s.n. *hook*); he cites Medville, the arms cited in Guillim. Parker's drawing is the skinniest fishhook of any, but it still shows the couped end to chief (though with the barb to sinister, which we'd call reversed).

So, fishhooks were period charges; the form found in Gelre and Guillim are the same, but with opposite default postures. All of the period heraldic fishhooks that we have found have a couped end; they do not terminate in a ring.

We are hereby declaring that the default fishhook matches that shown in Guillim and Siebmacher: the couped end is to chief and the curved end to base, the opening is to dexter with the barb on the inside of the curve. An example, courtesy of Bruce Draconarius of Mistholme, is shown at the end of this letter. A *fishhook inverted* has the couped end to base. A *fishhook reversed* has the opening to sinister.

A fishhook may terminate in a ring, rather than having a couped end; this will be considered an unblazonable, artistic detail. Fishhooks with the barb on the outside of the curve will be returned for redraw.
