

Errata

These are corrections to previous LoARs.

March 1980

Caid

Owain ap Caradawc. Name change from Echegaray of Shadow Valley.

When his name was registered in March 1980, the LoAR neglected to note that it was a name change.

December 1984

East

Lyanna of Kerneough. Device. Sable, a plate between four mullets in cross, a bordure argent.

When registered the LoAR failed to include a comma following the field in the blazon.

May 1987

Atenveldt

Elsibeth Merryweather. Name change from Elspeth Merryweather.

When her name was registered in May 1987, the LoAR neglected to note it was a change of name. Her old name, *Elspeth Merryweather*, is released.

March 1989

Outlands

Deidre of the Wilds. Badge for Tempus Perditum. A four-petalled rose saltirewise gules, barbed vert, charged with a chalice Or, all within a torse wreathed gules and Or.

When her household name and badge were registered, the LoAR misspelled her name as *Diedre of the Wilds*.

March 1993

Middle

Merouda Pendray. Badge for Sept Pendray. (Fieldless) A seeblatt inverted gules.

Appearing on the March 1993 LoAR as *(Fieldless) A seablatt inverted gules*, the primary charge was misspelled. It is a seeblatt.

October 1993

Caid

Davy Gunn of Scotland. Reblazon of badge. Sable, a demi-sun of five rays throughout argent, eclipsed sable, the center ray a Ken blade, issuant within and conjoined to an annulet argent.

When reblazoned in October 1993 as *Sable, a demi-sun of five rays throughout, eclipsed sable, the center ray a Ken blade, issuant within and conjoined to an annulet argent* the tincture of the sun was inadvertently dropped. It is argent.

November 1993

West

Dirk von den Schwarzenkatzen. Device change. Argent, a lion rampant contourny, queue forchy, on a chief sable three hearts argent.

When his new device was registered, the LoAR failed to note that his old device, *Per pale sable and argent, a fess counterchanged, three hearts argent and three cats rampant-counter-rampant guardant sable*, was released, per instructions on both the submission form and the Letter of Intent.

August 1994

Caid

Alexandria of the Isles. Name. Alexandria of the Isles.

Registered as *Alexandria of The Isles*, the LoAR mistakenly capitalized "the".

April 1998

Middle

Catherine Margaret Oakley of Rivendale. Device. Per pall argent, sable, and vert, a Catherine's wheel and an oak leaf argent.

This appeared as an acceptance on the April 1998 LoAR with the note "This was registered on the February 1998 LoAR." It should have been listed as a return. The device was registered, as noted, on the February 1998 LoAR with the blazon *Per pale vert and sable, a Catherine's wheel and an oak leaf, a chief triangular argent*.

May 1998

Atlantia

Barbara Giomaria di Roberto. Reblazon of augmentation. Argent, a chevron inverted azure, in chief a brown hen rising wings elevated and addorsed proper, for augmentation in base on an escutcheon sable a decrescent and a mountain of three peaks coupé argent.

Reblazoned as *Argent, a chevron inverted azure, in chief a brown hen rising wings elevated and addorsed proper, for augmentation in base on an escutcheon sable an decrescent and a mountain of three peaks coupé argent* the indefinite article wasn't changed when the blazon was corrected from *an increscent*.

February 1999

Atenveldt

Benedict of Luzern. Device. Quarterly gules and Or, in bend three cat's faces, a bordure engrailed counterchanged.

Blazoned as *Quarterly gules and Or, in bend three cats' face, a bordure engrailed counterchanged* when registered, the standard blazon term for the primary charge group is *cat's faces*.

January 2000

Ansteorra

Crystal of Middleford. Device. Per saltire vert and azure, a hippogriff segreant and a bordure argent.

When registered the LoAR failed to include a comma following the field in the blazon.

April 2000

East

Catriona Mairghread nic Dhuibh of Moray. Reblazon of badge. (Fieldless) In pale a talbot argent sejant atop a stool azure.

Listed on the April 2000 LoAR as a reblazon of device, it should have been listed as a reblazon of badge.

March 2002

West

Robin of Silverwood. Device. Sable, a winged cat segreant argent and a bordure embattled Or.

When registered the LoAR failed to include a comma following the field in the blazon.

May 2003

Atlantia

Leinhard Germeyn. Device. Sable, a crescent between two mullets in pale argent.

When registered the LoAR failed to include a comma following the field in the blazon.

August 2003

Atenveldt

Ivan Petrovich. Device. Argent, a pall inverted gules between two tortoises and a single-horned anvil reversed sable.

When registered the LoAR failed to include a comma following the field in the blazon.

September 2004

Calontir

Ragnarr Ulfsson sax. Device. Sable, a chevron inverted argent and in chief two eyes argent irised azure.

When registered the LoAR failed to include a comma following the field in the blazon.

Ealdormere

Roberto Valason. Device. Argent, a peacock in its pride azure gorged of a pearly coronet argent between two barrulets between two spouted pots reversed vert.

When registered the LoAR failed to include a comma following the field in the blazon.

Meridies

William Scott of Blackwater. Device. Azure, an enfield rampant Or and a bordure ermine.

When registered the LoAR failed to include a comma following the field in the blazon.

November 2004

An Tir

Catherine Townson. Device. Argent, a bend engrailed sable cotised plain azure.

When registered the LoAR failed to include a comma following the field in the blazon.

December 2004

Trimaris

Jessica of Fiach Ogan. Holding name and device. Per saltire azure and sable, a mullet of eight points elongated to base voided all within a bordure embattled argent.

In April 2006, the holding name *Jessica of Fiach Ogan* was replaced with the registered name *Aranwen ferch Dafydd Mawr*.

When registered the LoAR failed to include a comma following the field in the blazon.

Veronica da Milano. Device. Per bend sinister purpure and argent, a Latin cross argent and a peacock in his pride proper.

When registered the LoAR failed to include a comma following the field in the blazon.

February 2007

Calontir

Sherry Foxwell. Reblazon of device. Sable, a horse's head contourny extended palewise to chief coupé at the shoulders argent.

When reblazoned in 2007 the comma after the field was accidentally dropped from the blazon.

November 2009

An Tir

Mevanou verch Reys Yriskynit. Badge. Per pale azure and argent, a sun eclipsed counterchanged.

When registered the LoAR failed to include a comma following the field in the blazon.

February 2011

Middle

Hi{o,}rdís Ragnars dóttir. Device. Per pale vert and azure, a mullet of nine points Or and a chief engrailed argent.

When registered the LoAR failed to include a comma following the field in the blazon.

Trimaris

Ector Villalobos de Granada. Device. Per bend sinister wavy sable and gules, a horse's head coupé and a wolf's head coupé contourny argent.

When registered the LoAR failed to include a comma following the field in the blazon.

August 2011

Gleann Abhann

Collen ap Ifor. Badge. Per bend sinister rayonny purpure and argent, three gouttes one and two and a wingless horned demon affronty counterchanged.

When registered the LoAR failed to include a comma following the field in the blazon.

August 2013

An Tir

Viktor Kladivo. Device. Per chevron gules and sable, an owl's head cabossed and in chief a warhammer fesswise reversed argent.

When registered the LoAR failed to include a comma following the field in the blazon.

January 2014

Caid

Lachlann Magnússon. Name correction from Lochlann Magnusson.

When the name was registered, the LoAR inadvertently misspelled the name as submitted and as restored from the form given on the LoI.

September 2014

Gleann Abhann

Alexia of Thessalonica. Device. Per bend Or and purpure, a bec de corbin bendwise vert and a whelk bendwise Or.

When registered the LoAR failed to include a comma following the field in the blazon.

West

Anne of Bear's Haven. Device change. Or, a Celtic cross and on a chief vert a badger-hound statant Or.

When registered the LoAR failed to include a comma following the field in the blazon.

May 2015

Caid

Kale al-Raqqasa. Device change. Per saltire Or and argent, a polypus and a bordure purpure.

When her device, *Per saltire Or and argent, a polypus and a bordure purpure*, was registered the LoI and LoAR failed to note that this was a device change. Her prior device, *Per fess argent and vert, a brown weasel passant proper and a dexter hand argent*, is retained as a badge.

Zahrah al-Dimashqiyyah. Name. Zahrah al-Dimashqiyyah.

Appearing on the the LoAR as *Zahrah al-Dimashq iyya* the discussion noted that the name had been changed to *Zahrah al-Dimashq iyyah*. That change wasn't made.

June 2015

Middle

Red Spears, Barony of. Order name. Compagnia dei Porci Rossi.

Appearing on the LoAR as *Compagnia dei P órci Rossi*, it was noted that the acute accent had been removed from *Porci Rossi* because it was a modern editorial addition. However, the accent wasn't actually removed.
