## From Laurel: LoPaD item: Registration Limit

In the December 2019 Cover Letter we called for a discussion of increasing the registration limit for individual submitters from six to ten items. There was a great deal of feedback; we agree with those who feel that this would improve our customer service with minimal problems, given that some people are at the registration limit, but not many.

The text of the relevant part of the Administrative Handbook will now read (insert/delete version):

Individuals may register no more than six ten names and six ten pieces of armory. Any submission by an individual which would otherwise exceed this limit must be accompanied by a release of one or more items already registered to that individual to accommodate the new item[s]. Neither heraldic titles nor augmentations count as items for this purpose, though the arms to which the augmentation is added do.

## From Laurel: Sign Herald Deputy Applications Sought

In order to encourage and promote the use and equality of Sign/Silent Heraldry at all courts and events in which the entire populace attends, and to assist the sign/silent heralds in their dealings with the Crown, the Silent Heraldry Deputy of Laurel Sovereign of Arms coordinates efforts and communication throughout the SCA. Sign/Silent Heralds in the Society are heralds who express auditory information into visual and/or tactile information used by deaf and hard-of-hearing people.

This deputy is tasked with the following duties, plus other such tasks as assigned by Laurel:

- Working with Kingdoms to improve the organization of sign heraldry and its integration with other court and event heralds.
- Working with Kingdoms and Laurel to improve education regarding sign heraldry, both for sign heralds themselves and the general populace.
- Acting as a resource for sign herald programs.
- Preparing quarterly reports to Laurel on the status of such programs.

### From Pelican: Venetian Equivalent Titles

In her March 27, 2020 Letter, Palimpsest proposed a series of equivalent titles in the Venetian dialect, based on research work done by Signor Giovanni Loredan of Calontir. Although they were uncapitalized on the Letter of Intent, these titles have been capitalized to be consistent with our treatment of titles in the Society. We hereby accept the following as official alternate titles and direct Palimpsest to update the List of Alternate Titles (under both the Italian language groups) accordingly.

- *Nobel* for Award or Grant of Arms (gender-neutral)
- Dona for Award or Grant of Arms (female)
- Madona for Award or Grant of Arms (female)
- Misier for Award or Grant of Arms (male)
- Signor for Award or Grant of Arms (male)
- Barom for Barony (male)
- Chavalier for Knight (male)
- Maistro for Other Peerage Order (male)
- Vischonte for Viscounty (male)
- Principesa for Coronet (female)
- Prinzipe for Coronet (female)
- Principo for Coronet (male)
- Chontesa for County (female)
- Chonte for County (male)
- *Conte* for County (male)
- Duchesa for Duchy (female)
- *Ducha* for Duchy (male)
- Raina for Crown (female)
- Re for Crown (male)

The proposed alternate title *Doxie* is not accepted because of its similarity to an English slang term for a prostitute.

We thank Signor Giovanni for his hard work and contributions.

### From Pelican: Catriona and Heather

This month, commenters provided evidence that the FamilySearch Historical Records showing *Catriona* and *Heather* as English given names were, in fact, mistaken transcriptions. Apart from the single FamilySearch record, we were unable to find any evidence of *Catriona* as a period given name. Therefore, this month is the last in which that name can be registered until we find other evidence supporting it. Fortunately, *Heather* continues to be registerable because it is also a 16th century English surname that can be used as a given name.

I will be asking Codex to modify my article "Something Rich and Strange: 'Undocumentable' Names From The IGI Parish Records" accordingly.

#### From Pelican: Award and Order

In the past few months we have received several submissions that mistakenly assumed that the standards and precedents governing order names do not apply when the designator *Award* is used. This is not the case. "Order name" is a catch-call term for any name that is used for an order or award given out by Society nobles (Crowns, Coronets, Barons or Baronesses, etc.). The specific designator used for an order name does not affect the rules that govern that name or how must be constructed. Thus, a submission for *Award of X* is governed by the same rules and precedents as a submission for *Order of X*.

## From Wreath: Continuing the Transition and Division of Labor

As is customary, when we break in a new Sovereign of Arms, we do it gently by splitting the workload. This month, the decisions were split as follows:

For the month of June, Cormac wrote the decisions for the Kingdoms of Æthelmearc, An Tir, Ansteorra, Artemisia, and Atenveldt, while Oddr handled the remainder of this month's letters.

# From Wreath: Claims of Marshalling - Order of Operations (Part 2)

Last month's Cover Letter gave instructions on how to use SENA A6F to determine whether a piece of armory was presumptive due to the appearance of marshalling. This month, we had another instance where commenters brought up the possibility of marshalling, which provides a fine example of how to use this section of SENA: The device submission of Savaric of Sussex, *Quarterly gules and vairy argent and sable, a cross between in bend two crosses flory Or.* 

A6F1 clears armory of the appearance of marshalling. However, the field is neither plain nor divided with a field other than per pale or quarterly (a) and does not have a complex line of division (b). And while it does have a single charge over the entire field (c) crosses are explicitly called out in the rule as not exempting from the appearance of marshalling.

A6F2 returns armory that is unambiguously marshalling. However, it has no charges that terminate in the end of a section (a), no subdivided sections (b), no multiple types of primary charges (c), and no multiple charges in a given section (d).

A6F3 determines, in order, whether the armory is marshalling if the previous sections didn't rule one way or the other. And A6F3a states that "When each section of the design appears to be an independent coat of arms, it creates the unmistakable appearance of marshalling. A section of the design does not appear to be an independent coat of arms if it is a plain tincture, including a fur, which we do not protect as arms." The vairy argent and sable portions of the field are uncharged, and therefore qualify under this rule. Therefore, this device does not appear to make any claim of marshalling.
