Adding Wings to *Proper* Charges

- SENA A3B1 is updated to allow animate and inanimate charges *proper* have wings of a heraldic tincture (or tinctures) added to them.
- What this means:
 - Prior to this change you could register *a bear argent winged Or* but not *a bear proper winged Or*. Now you can register either.
 - You can not add brown wings to a charge as brown is not a heraldic tincture.



Period example, from Siebmacher, "Ein roter Schild / der karpf darin an seiner farb mit w[eiss] flügeln" = "A red shield, the karp therein in its colour [ie. 'proper'] with white wings"

Old Norse Element v{o,}lva

- Precedent allowing the registration of the Old Norse name elements v{o,}lu- and v{o,}lva-, meaning seeress/prophetess/sibyl/wise-woman, is overturned. These names were only used by women that were understood to have the power of prophecy.
- These name elements have previously been registered as pre-pended bynames. As of the release of the January 2022 LoAR the elements are no longer registrable, whether pre-pended or as separate byname.

From the LoAR: Names

- In registering the household name *Kameike* [Kamei Kojirou Yoshi'naga, A-Artemisia] Pelican noted that the suffix *-ke* when appended to a Japanese surname indicates a group based on a house of any sort of lineage. It is an acceptable household designator.
- The Greek letter zeta may be transliterated as either *z* or *dz*. [Madzaia of Jararvellir, A-Northshield]

From the LoAR: Armory

- *Llamas* no longer carry a step from core practice as they were documented as known to period people as shown by their use in indigenous artifacts dated to the first millennium CE as well as the medieval era. They were also known to 16th C Europeans. [Úlfeid̥r á Þróndheimi, Ansteorra]
- A *pink lily of the valley proper* is considered *vert* for conflict purposes as a lily of the valley takes its tincture from its leaves. [Zoete Steenhagen, A-Calontir]

From the LoAR: Armory

- A small amount of ground underneath a *hurst* is considered an unblazonable, artistic detail. [Ellisif Gyðadottir and Jon Fitz John, A-Drachenwald]
- Acorns added to a single leaf (not a tree) are maintained charges and count for difference. Precedent was confirmed that there is no difference for inverting an oak leaf. [Guy de Craven, A-East]

From the LoAR: New Charges

- *Rose aversant*, a period charge. Wreath declined to consider whether there is a DC between a *rose aversant* and a normal (*affronty*) rose. [Jessimond of Emerickeskepe, A-Ansteorra]
